In the State of the Art Gallery's 15th Annual

JURIED PHOTOGRAPHY SHOW

Friday, March 5 — Saturday, March 27, 2004

A minimum of \$500 in prizes

To Enter: Fill out the entry form (bottom section), detach and bring it **with a check for \$30 made out to "State of the Art Gallery,"** along with your work for judging (see below). It is not necessary to mail it in advance. Our address is: 120 West State St., Ithaca, NY, 14850. **Keep this top portion of the form so you will retain information about the show.**

Each entrant may submit **up to three works**. All should be current and original, fully ready to hang, and use photographic processes in their creation. The works should not have been submitted to State of the Art Gallery (SOAG) competitions in the past. Current members of SOAG may not exhibit in this show. **Each work must be accompanied by three index cards** stating: the work's title; the entrant's name, address and phone number; technique (how you did it, e.g., "negative and c-print" or "digital image manipulated in Photoshop"); and price if for sale, "NFS" if not. Attach one card firmly to the back of the work; the other two cards must be attached to the front and be easily detachable.

Work should be brought to the gallery on Sunday, February 29, 5-8 PM or Monday, March 1, 3-7 PM. The DEADLINE for FORMS, FEE, AND WORK is 7 PM MARCH 1. THE ENTRY FEE IS NON-REFUNDABLE AND DOES NOT GUARANTEE THAT YOUR WORK WILL BE SHOWN. If you cannot get your prints to the gallery on February 29 or March 1 please contact Bill Evans at 607-277-7551 to make other arrangements. Entrants whose work is not selected for exhibition will be notified promptly and must pick up their work by Sunday, March 7, at the latest. We prefer that you pick up your work on Thursday, March 2, between 2 and 7 PM.

Selection & Prizes: Works chosen for hanging in the show, and those awarded prizes, will be selected for artistic excellence and technical competence, with consideration for quality of presentation as well. A panel of artist members of the State of the Art Gallery will do jurying (deciding what will hang in the show). **Well-known photographer Charles Love will do prize judging.** The show is made possible in part with public funds from the Community Arts Partnership of Tompkins County/New York State Council on the Arts Decentralization Program.

Celebration and Prize Awards will take place on Saturday, March 6, 2004 from 5 to 8 PM. All entrants and their guests are invited. Prize presentation will take place at 6:30 PM. Work included in the show must be picked up on Sunday, March 28, noon-8 PM.

While the State of the Art Gallery, its members and agents will make reasonable efforts to protect your work, we cannot indemnify you against loss or damage to your work. In submitting your work to us you agree that the State of the Art Gallery is not liable and must be held harmless if your work is damaged or lost. Additionally you are agreeing that your work may be reproduced for the purpose of publicizing the show.
